Eligibility

This opportunity is available to Maine bachelor's and master's level behavioral health practitioners who serve youth up to age 16. Preference will be given to licensed master's level behavioral health clinicians. <u>Accepted applicants must accredit in all four (4) interventions</u>.

Cost

- These virtual Triple P trainings are offered at **no cost**.
- Participants will be reimbursed for their time in training and accreditation.
- Additional copies of implementation materials will be provided after accreditation.

Requirements of accepted participants

- Experience working with youth and families.
- Provision of services in outpatient, home and community-based treatment, schoolbased, residential and/or inpatient settings.
- Active participation in all training, pre-accreditation, and accreditation days. • There will not be an opportunity to make up missed training days.
- Accreditation in all four Triple P interventions.
 - Role playing is required as part of training and accreditation.
- Involvement of parents and caregivers in sessions.
 - Participants must be able to actively meet and work directly with parents.

Financial Reimbursement

To offset potential productivity losses, participants will be reimbursed for their time in the Triple P Standard, Standard Teen, Pathways and Group training, pre-accreditation and accreditation. Reimbursement will be made according to the table below:
